Highway:

Geigle was present to express her concern with the damage recovery process due to her not notifying the Assessor’s office of her property changing to owner occupied to prove primary residence. Kotab informed the Commission that he would like to plan a meeting with the community and Commissioners to explain more of this process. The Commission advised Kotab to move forward with planning and will notify them of a date and time. No further action taken.

Drainage:

Paul Voigt and Highway Super. – Doug Cimpl were present to discuss a possible drainage project in Rouse Township that Voigt may be submitting an application for a drainage permit. The Commission advised Voigt that all drainage must be approved by all landowners with signature and drain into a blue line water feature. When those requirements are met he may submit them with the application and after 2 weeks of publication they will be presented to the Commission for review. No further action taken.
