**Special Session – March 24, 2020**

The Charles Mix County Board of Commissioners met in special session on the 24<sup>th</sup> of March, 2020 at 9:30 am. Chairman - Neil Von Eschen opened the meeting with the Pledge of Allegiance and called the meeting to order with Vice Chairman - Nick Stotz, Commissioner – Keith Mushitz, Auditor - Danielle Davenport, States Attorney – Steve Cotton, Emergency Disaster Manager – Mike Kotab, Wagner Finance Officer – Becky Brunsing, Wagner Councilman – Roger Schroeder, Town of Dante – Dick & Ann Rysavy, Geddes Finance Officer – Donna Paulson, Geddes Mayor – Dan Schulte, Lake Andes Finance Officer – Debbra Houseman, Lake Andes Mayor – Ryan Frederick, Platte Finance Officer – Shauna Meyerink, Platte Mayor – Steve Christensen and Pickstown Board President – Cindy Broyhill present.

**Agenda:**

A motion was made by Stotz and seconded by Mushitz to approve the agenda as presented. All in favor, motion carried.

**COVID-19 Pandemic:**

ED Manager – Mike Kotab opened with the Governors COVID-19 Executive Order concerning businesses across the state and wanting all entities informed on steps that can be taken. Kotab and States Attorney - Cotton discussed resolutions and ordinances that have been approved by other counties. Kotab then opened the floor for questions/discussion.

**City Officials/Public Comment:**

City of Platte Mayor – Steven Christensen informed the Commission of Platte Hospital’s request to follow the Governors Executive Order due to precautions and facility size. Discussion was held regarding hospitals in Charles Mix County and their capability to care for the pandemic.

Numerous topics were brought to the table: closing businesses, curbside service, recreation areas, elections and public meetings. Officials stated that most city and county businesses have implemented preventative measures. All in attendance agreed to circulate more COVID-19 information to children and families.

Kotab talked about CDC guidelines and actions that could be taken to enforce an ordinance if the city or county were to approve one.

**Ordinance:**

A motion was made by Mushitz and seconded by Stotz to approve Ordinance 2020-02 COVID-19; presented by States Attorney - Cotton. All in favor, motion carried.

**ORDINANCE NO. 2020-02  
COVID-19**

AN EMERGENCY ORDINANCE TO ADDRESS A PUBLIC HEALTH CRISIS BY IMPLEMENTING CERTAIN MEASURES WHICH HAVE BEEN DEEMED NECESSARY TO SLOW THE COMMUNITY SPREAD OF CORONAVIRUS (COVID-19).

WHEREAS, the Charles Mix County Commission has the authority to pass ordinances for the purpose of promoting the health, safety, morals and general welfare of the community, and the promotion of health and the suppression of disease; and

WHEREAS, an outbreak of the disease COVID-19, which is caused by the novel coronavirus, has been confirmed in more than 100 countries, including the United States; and

WHEREAS, COVID-19 is a severe respiratory disease transmitted by person-to-person contact, or by contact with surfaces contaminated by the virus. In some cases, especially among older adults and persons with serious underlying health conditions, COVID-19 can result in serious illness requiring hospitalization, admission to an intensive care unit, and death; and

WHEREAS, the World Health Organization (WHO), the Centers for Disease Control and Prevention (CDC), and the Secretary of the U.S. Department of Health and Human Services have declared the outbreak of COVID-19 as a public health emergency; and

WHEREAS, on March 13, 2020, the President of the United States declared a national emergency in response to the global pandemic of COVID-19; and

WHEREAS, on the same day, Governor Kristi Noem, issued Executive Order 2020-04 which declared a state of emergency to exist in the State of South Dakota in response to the spread of COVID-19; and

WHEREAS, the CDC and health experts have recommended social distancing to slow the spread of COVID-19; and

WHEREAS, social distancing is a method of slowing down or stopping the spread of a contagious disease by reducing the probability of contact between infected persons and those not infected in order to minimize disease transmission; and

WHEREAS, in response to the need to implement social distancing all schools in the state have been closed for at least two weeks; and

WHEREAS, on March 16th, the White House issued guidance recommending that social gatherings of more than ten people be avoided, and that people avoid eating or drinking at bars, restaurants, and food courts; and

WHEREAS, the guidance issued by the White House further recommended that in states with evidence of community transmission, bars, restaurants, food courts, gyms, and other indoor and outdoor venues where people congregate should be closed; and

WHEREAS, many states and communities across the country have already implemented the White House recommendations by ordering all bars, restaurants, food courts, gyms, and other indoor and outdoor venues where people congregate be closed until the public health emergency is over; and

WHEREAS, the failure to successfully implement social distancing will likely result in higher numbers of infected individuals and has the potential to overwhelm the capacity of the County's health care providers; and

WHEREAS, it is important that control measures be taken to reduce or slow down the spread of COVID-19 in order to protect the health and safety of the County's residents, especially for seniors and those with underlying health conditions that make them particularly vulnerable to COVID-19.

NOW THEREFORE, BE IT ORDAINED, by the Charles Mix County Commission that:

1. Effective at 12:00 a.m. on March 25, 2020, all restaurants, food courts, coffee houses, bars, breweries, distilleries, wineries, clubs, cafes and other similar places of public accommodation offering food and beverages for on-site consumption, including any alcohol licensees with on-sale privileges, are directed to close to on-site/on-sale patrons. These businesses may continue to operate in order to provide take-out, delivery, curbside service, drive-thru service. Any business continuing to operate in order to provide off-site service should implement procedures to ensure social distancing and operate in compliance with federal and state health guidance in order to prevent the spread of COVID-19.
2. Effective at 12:00 a.m. on March 25, 2020, all recreational facilities, public pools, health clubs, athletic facilities and theaters, including movie theaters and music or entertainment venues are directed to close and cease operations.
3. Effective at 12:00 a.m. on March 25, 2020, all hookah lounges, cigar bars, vaping lounges or other similar business which allow for on-site consumption are directed to cease allowing on-site consumption, but may continue to offer products for sale to consume off-site under the same conditions as bars and restaurants outlined in paragraph #1.
4. Effective at 12:00 a.m. on March 25, 2020, all arcades, bingo halls, bowling alleys, indoor climbing facilities, skating rinks, trampoline parks, and other similar recreational or entertainment facilities are directed to close and cease operations.
5. The prohibitions and closures in this order do not apply to the following businesses:
  - a. Places of public accommodation that offer food and beverages for off-site consumption, including grocery stores, markets, retail stores that offer food, convenience stores, pharmacies, drug stores, and food pantries, other than any portion of such business which would be subject to the requirements of paragraph #1.
  - b. Room service in hotels.
  - c. Health care facilities, residential care facilities, congregate care facilities, and correctional facilities.
  - d. Crisis shelters, homeless shelters, soup kitchens, or other similar institutions.
  - e. Airport concessionaires.
  - f. Any emergency facilities necessary for the response to the current public health emergency or any other community emergency or disaster.
6. This ordinance shall remain in effect until such time as it is amended or repealed.
7. Any violation of this ordinance is subject to the general penalty provision in

SDCL 7-18A-32. Each day a violation of this ordinance is allowed to occur is considered a separate offense. BE IT FURTHER ORDAINED, that this ordinance is necessary for the immediate preservation of the public peace, health, safety, and welfare of Charles Mix County and shall become effective immediately upon passage.

**RESOLUTION NO. 2020-03  
COVID-19**

AN EMERGENCY RESOLUTOIN TO ADDRESS A PUBLIC HEALTH CRISIS BY IMPLEMENTING CERTAIN MEASURES WHICH HAVE BEEN DEEMED NECESSARY TO SLOW THE COMMUNITY SPREAD OF CORONAVIRUS (COVID-19).

WHEREAS, cases of COVID-19 have been determined to have a substantial impact in counties across, South Dakota; and

WHEREAS, there are certain measures necessary to stop the spread of COVID-19; and

WHEREAS, the Charles Mix County Commission finds it to be in the best interest of the public well being to enact certain measures; and

NOW THEREFORE, BE IT RESOLVED that the Charles Mix County Commission hereby implements the following requirements:

- Practice proper hygiene. Wash and/or sanitize hands frequently. Cough into your elbow.
- Practice self-isolation.
- Practice social distancing.
- No groups of 10 or more people allowed socially or at a business.
- Stay at home and contact your medical provider if you believe you have symptoms. Especially a fever, cough, or shortness of breath.
- Please limit trips to purchase essential items.
- Please limit the time spent purchasing essential items.
- Stagger work schedules.
- All County offices are operating with limited public access to the buildings.
