Regular Session – October 15th, 2020

The Charles Mix County Board of Commissioners met in regular session on the 15th of October, 2020 at 10:00 am. Chairman – Neil Von Eschen opened the meeting with the Pledge of Allegiance and called the meeting to order with Vice-Chairman – Nick Stotz, Commissioner – Keith Mushitz, Auditor – Danielle Davenport, Deputy-Auditor, Crissy Longe and Custodian – Randy Winckler present. Colin Soukup was present after the meeting was called to order.

Agenda:

A motion was made by Stotz and seconded by Mushitz to approve the agenda as presented. All in favor, motion carried.

Minutes:

A motion was made by Stotz and seconded by Mushitz to approve the minutes as presented. All in favor, motion carried.

Bills:

A motion was made by Stotz and seconded by Mushitz to approve the bills for 10/1/2020. All in favor, motion carried.

A motion was made by Mushitz and seconded by Stotz to approve a cash transfer from the General Fund to the following funds - 911 Fund in the amount of \$100,000 and the M & P Fund in the amount of \$15,000. All in favor, motion carried.

New Account:

A motion was made by Stotz and seconded by Mushitz to open a new non-interest-bearing checking account at Andes State Bank for the new MERP insurance plan and make Auditor – Davenport the administrator. All in favor, motion carried.

Plat:

A motion was made by Mushitz and seconded by Stotz to approve the Plat Lot 13 Platte Creek Riverside Acres Addition located in the E ½ of Section 23, Township 98 N, Range 69 W of the 5th Principal Meridian, Charles Mix County, South Dakota. All in favor, motion carried.

Holiday:

Discussion was held regarding state declared holiday leave. Charles Mix County will be closed Thursday - November 26th, Friday - November 27th, Thursday - December 24th & Friday - December 25th in observance of Thanksgiving and Christmas holidays.

Highway:

Highway Superintendent – Doug Cimpl met with the Commission and discussion was held regarding the purchase of a new motorgrader or extending the warranty. Further discussion to be held at the 10/22/20 meeting. Flooding damages to culverts and roads were also discussed with no action taken.

A motion was made by Stotz and seconded by Mushitz to approve the hiring of Jessica Tschumper to the position of Highway Administrative Assistant at a rate of \$13.00 per hour starting 10/21/20. All in favor, motion carried.

City of Lake Andes:

City of Lake Andes Attorney – Tim Whalen (representing Dan Cahoy) met with the Commission to discuss the county owned parcel 29.50.25.001 which is between Charles Mix County States Attorney office and Cahoy General Store. Surplus and sale options were discussed with no action taken.

Sheriff:

Sheriff – Randy Thaler was present and informed the Commission that he had purchased new body cameras for his deputies and jailers as well as vehicle cameras. All cameras purchased would be reimbursed with a grant obtained through the State of South Dakota. No action taken.

A motion was made by Stotz and seconded by Mushitz to accept Deputy Sheriff – Isaac Sauder’s resignation with a last day of work being 10/29/2020 and vacation pay out of 72 hours. All in favor, motion carried.

Flooding:

Lynn Soukup met with the Commission and Highway Superintendent – Cimpl to discuss flooding from a new culvert placed on SD Hwy 281 that is affecting 294th St in Bryan Township. Culvert placement and the option of a hydrology study were discussed. Cimpl to contact Brosz Engineering with no further action taken.

Tax Freeze:

Director of Equalization – Denise Weber presented a resolution to the Commission regarding Austin Weber’s tax freeze request. A motion was made by Stotz and seconded by Mushitz to approve Resolution 2020-10. All in favor, motion carried.

Resolution 2020-10

Declaration of beginning farmer designation for parcel 04.68.4010 owned by Austin Dean Weber. WHEREAS, Austin Dean Weber is the owner of parcel 04.68.4010 legal description N ½ - SE ¼ THEREOF (parcel number assigned by Charles Mix County Equalization Office) located in Charles Mix County, South Dakota, meet the criteria of SDCL 10-6-31.5 to qualify as a beginning farmer; and WHEREAS, by virtue of meeting the criteria set forth in SDCL 10-6-31.4, such parcel may be granted a tax freeze for five (5) years in accordance with the provisions of SDCL 10-6-31.5; and WHEREAS, the granting of such designation is discretionary with the Charles Mix County Board of Commissioners; and

WHEREAS, The Charles Mix County Board of Commissioners is willing to grant such designation upon the terms and conditions hereinafter set forth.

NOW THEREFORE BE IT RESOLVED, that the Charles Mix County Board of Commissioners grants beginning farmer status to Austin Dean Weber as the owner of parcel 04.68.4010 as designated by the Charles Mix County Equalization Office; and

BE IT FURTHER RESOLVED, that the granting of the beginning farmer status be for a period of five years from the assessment year 2020 taxes payable 2021 with the taxes upon such property be frozen at 85.570 for the period of time from 2020 ending 2025, except that the tax freeze so granted shall not apply to any new buildings or structures which may be constructed upon such property during the period of the tax freeze.
