Regular Session – April 22nd, 2021

The Charles Mix County Board of Commissioners met in regular session on the 22^{nd} of April 2021 at 10:00 am. Chairman – Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order with Vice-Chairman – Keith Mushitz, Commissioner – Colin Soukup and Auditor – Danielle Davenport present.

Agenda:
