# CHARLES MIX COUNTY Board of Commissioners Regular Session – December 23, 2021

The Charles Mix County Board of Commissioners met in Regular Session on Thursday the 23<sup>rd</sup> of December 2021 at 10:00 am. Chairman – Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order, with Vice -Chairman- Keith Mushitz, Commissioner- Colin Soukup, and Auditor- Jason Gant present.

## Agenda:

A motion was made by Mushitz seconded by Soukup to approve the agenda. All in favor, motion carried.

## Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the December 9, 2021, meeting. All in favor, motion carried.

#### Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for December 23, 2021. All in favor, motion carried.

## **Liquor License:**

A motion was made by Mushitz and seconded by Soukup to approve the issuance of the following liquor license application. All in favor, motion carried.

Full Choke Lodge LLC, 38807 294th St Ravinia, SD 57356; Retail (on-sale) Liquor License.

#### **Public Comment:**

The Commission visited with Perry Pesick and Joe Steinmark who had concerns about any plans by the Commission to change a road from oil to gravel. The Commission explained that there are no current plans to change any roads from oil to gravel.

## **Opioid Settlements:**

Auditor – Jason Gant visited the Commissioners regarding Opioid Settlements that have the potential for funds for Charles Mix County. States Attorney – Steve Cotton recommended signing up for the Opioid Settlements. A motion was made by Mushitz and seconded by Soukup to approve the Settlements and have Auditor – Gant complete the sign-up. All in favor, motion carried.

## Highway:

Highway Superintendent – Doug Cimpl visited with the Commissioners regarding new equipment. A motion was made by Mushitz and seconded by Soukup to approve the trade-in of the 2015 John Deere 772GP for \$115,500.00 and the purchase of the 2021 Caterpillar 150-15AWD for \$271,079.41. All in favor, motion carried.

# **Sheriff:**

Sheriff – Randy Thaler visited with the Commissioners regarding Non-Compete contracts. No action taken.

# **Prisoner Housing:**

The Commission was presented the 2022 Minnehaha County Juvenile Detention Center Agreement with a rate of \$257.00 per bed, per day. A motion was made by Mushitz and seconded by Soukup to approve the Agreement and have Chairman – Stotz sign. All in favor, motion carried.

The Commission was presented the 2022 Charles Mix County Prisoner Housing Agreements with Aurora, Bennett, Bon Homme, Douglas, Gregory, Hand, Hanson, Hutchinson, Hyde, Jerauld, Mellette, McCook, Miner, Moody, Sanborn, Spink, Turner and Union Counties to house their prisoners at the rate of \$70.00 per prisoner, per day. A motion was made by Mushitz and seconded by Soukup to approve the Agreements and have Chairman – Stotz sign. All in favor, motion carried.

#### Law Enforcement Services:

The Commission was presented the 2022 City of Lake Andes Agreement for Law Enforcement Services with a rate of \$117,000 per year commencing January 1, 2022, to December 31, 2022, with payments paid monthly at a rate of \$9,750.00. A motion was made by Mushitz and seconded by Soukup to approve the Agreement and have Chairman – Stotz sign. All in favor, motion carried.

#### Personnel:

A motion was made by Mushitz and seconded by Soukup to accept Damon Griffith's resignation from his position as Deputy Sheriff and December 27, 2021, being his last day of employment. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to accept Matthew Hennion's termination from his position as Jailer and December 13, 2021, being his last day of employment. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the hire of Trevor Durmeir for the Deputy Sheriff position at the rate of \$18/hour. All in favor, motion carried.

A motion was made by Stotz and seconded by Soukup to have Marcia Bierman train in the Treasurer's Office for up to 3 hours the week of December 27<sup>th</sup> and up to 3 hours the week of January 3<sup>rd</sup> to ensure continuity of operations. Vote of 2 in favor, with Mushitz abstaining, motion carried.

#### **Public Comment:**

The Commission visited with Larry Smejkal and Dave LaCompte who had concerns about roadway access. The Commission will review and discuss further. No action taken.

# **New Commissioner Districts-First Reading:**

Auditor – Jason Gant presented to the Commission the proposed 2022-2030 New Commissioner Districts map and ordinance.

A motion was made by Mushitz and seconded by Soukup to approve the New Commissioner Districts Ordinance 2021-03 First Reading and scheduled the Second Reading for February 10, 2022. Roll Call vote was called for with Stotz-Yea, Mushitz-Yea, and Soukup-Yea, 3-0 in favor, motion carried.

## **ORDINANCE #2021-03**

An Ordinance of Charles Mix County

**Commissioner Districts** 

BE IT ORDAINED BY THE CHARLES MIX COUNTY COMMISSION THAT COUNTY COMMISSIONER DISTRICTS 1, 2, & 3 ARE AS FOLLOWS:

The County shall be divided into three districts and said districts shall be designated respectively as District 1, District 2, and District 3. Any reference to street or avenue below shall mean an imaginary line running down the approximate middle of each street or avenue. The districts of Charles Mix Conty are set forth below and the map thereof. Any discrepancies shall be resolved by reference to the map, attached and incorporated herein by reference, rather than the physical descriptions set forth herein.

#### **DISTRICT 1**

The first commissioner district shall embrace all territory in the county boundary in county of

Charles Mix lying and being from the centerline of 379th Ave and centerline of 288th St,

south along the centerline of 379<sup>th</sup> Ave to the driveway located at the northwest corner of NW ¼ SW ¼ of Section 1-96-66 east following driveway to electrical transmission highline, in Sections 1-96-66, 12-96-66, 13-96-66, 18-96-65, 19-96-65 and 20-96-65, to centerline of 295<sup>th</sup> St,

east along the centerline of 295<sup>th</sup> St to the centerline of US Hwy 18/281, south along the centerline of US Hwy 18/281 to the city limits of Pickstown, east along the city limits of Pickstown to the centerline of SD Hwy 46, northeasterly along the centerline of SD Hwy 46 to east section line of Section 3-95-65, south along the east line of Section 3-95-65 to southeast corner of Section 3-95-65, west along the south section line of Section 3-95-65 to northwest corner of NE ¼ of Section 10-95-65,

## DISTRICT 2

east following the driveway along to electrical transmission highline southeasterly along in Sections 1-96-66, 12-96-66, 13-96-66, 18-96-65, 19-96-65 and 20-96-65, to centerline of 295th St, east along the centerline of 295th St to the centerline of US Hwy 18/281, south along the centerline of US Hwy 18/281 to the city limits of Pickstown east to the centerline of SD Hwy 46, northeasterly along the centerline of SD Hwy 46 to east section line of 3-95-65, south along the east line of Section 3-95-65 to southeast corner of Section 3-95-65. west along the south section line of Section 3-95-65 to Northwest corner of NW ¼ NE ¼ of Section 10-95-65, south from the northwest corner of NW % NE % of Section 10-95-65 to southeast corner of SE %SW ¼ of Section 10-95-65, west along the south line of Section 10-95-65 and Section 9-95-65, to the Charles Mix County Boundary, northwest following the Charles Mix County boundary, then east following the Charles Mix County Boundary to the centerline of 374th Ave, south along the centerline of 374th Ave to centerline of 277th St then east to centerline of 375th Ave, the place of beginning.
