Jail Study Presentation:

Sheriff Randy Thaler and Chief Deputy Sheriff Derik Rolston introduced representatives from HMN Architects and GA Johnson Construction to present additional findings on cost estimates for various new and remodeling plans for County jail needs. Discussion was held. The Commission decided to wait until the Legislature's Summer Study Committees on Jails concluded before making any decisions. No action taken.

Sheriff's Office:

Sheriff Thaler discussed the three checking accounts that he oversees. No action taken.

Highway Department:

Highway Superintendent Doug Cimpl discussed the status of fuel bids, the purchase of a new blade, the need for a new Lake Andes Highway Shop, and the Lake Platte Bridge.

A motion was made by Mushitz and seconded by Soukup to approve the purchase of a new blade at \$433,337 and sell the old blade to a local government if possible. All in favor, motion carried.
