Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Colin Soukup, Commissioner Keith Mushitz and Auditor Jason Gant present.

Agenda:

A motion was made by Soukup and seconded by Mushitz to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Mushitz and seconded by Soukup to approve the minutes from the July 28, 2022, Board of Commission regular meeting. All in favor, motion carried.

Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for August 11, 2022. All in favor, motion carried.

Public Comments:

Neil Von Eschen visited with the Commission requesting \$5,000 from the County for a new roof for the Charles Mix County Historical Museum in Wagner. No action was taken. Mr. Von Eschen also requested more information regarding the paving of a section of the old SD Highway 50 near Wagner. More information will be gathered. No action was taken.

Weed Department:

Weed Supervisor Josh Rouse and Assistant Dustin Hartley visited with the Commission about the current state of weeds in the County and what plans are underway for the remainder of the year as well as planning for 2023. No action was taken.

Highway Department:

Superintendent Doug Cimpl discussed hiring two new employees, an overlay project, and the old SD Highway 50 paving project. No action was taken.

County Vehicles:

Director of Equalization Denise Weber discussed the need to surplus the SUV and one of the cars. A motion was made by Mushitz and seconded by Soukup to obtain two bids and to approve the purchase of a new vehicle similar to a GMC Terrain. All in favor, motion carried.

2022 Tax Deed Sale:

Auditor Gant reviewed the list of properties that are delinquent on tax payments. Property owners on the list have until August 26th to pay all outstanding taxes. The Tax Deed Sale is scheduled for September 22nd at 1pm at the Courthouse. No action taken.

Law Enforcement Contract:

Auditor Gant presented Sheriff Randy Thaler's new Law Enforcement contract that was agreed to with the City of Lake Andes with an increase in payment to the County of \$22,560 per year. No action taken.

2023 Budget:

Auditor Gant reviewed the special interest list of various nonprofits requesting funds for the 2023 fiscal year. No action taken.

New Platte-Winner Bridge:

A motion was made by Mushitz and seconded by Soukup to sign a letter of support to the US Department of Transportation regarding the need for a new Platte-Winner Bridge. All in favor, motion carried.

Charles Mix Electric:

A motion was made by Mushitz and seconded by Soukup to sign a letter detailing which County owned properties had permission to retire the line and physically remove electrical service. All in favor, motion carried.
