CHARLES MIX COUNTY Board of Commissioners Regular Session – August 25, 2022

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, August 25, 2022, in the County Courtroom. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Colin Soukup, Commissioner Keith Mushitz and Auditor Jason Gant present.

Agenda:

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the August 11, 2022, Board of Commission regular meeting. All in favor, motion carried.

Bills:

A motion was made by Soukup and seconded by Mushitz to approve the bills for August 25, 2022. All in favor, motion carried.

Plats:

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Lot 1, Hugg Addition in the NW1/4 of Section 26, T98N, R68W of the 5^{th} P.M., Charles Mix County, South Dakota. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Lots A & B in Lot 3 of Block 2, Kuiper Addition to the City of Platte Charles Mix County, South Dakota. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Lots A, B, C, & D in Tract 1 of Block 53, Milwaukee Land Company's 4th Addition to the City of Platte, Charles Mix County, South Dakota. All in favor, motion carried.

Drainage Hearing:

The Public Hearing was opened with no protest present. A motion was made by Mushitz and seconded by Stotz to approve the Drainage Permit 2022-06 of Michael Schulte for the SE1/4 of Section 28, T98N, R66W of the 5th P.M., Charles Mix County, South Dakota. All in favor, motion carried.

Gregory County Pumped Storage Project:

The Commission invited both the proponents and opponents of this project to visit regarding their concerns with around 40 people in attendance. Missouri River Energy Services representatives spoke about the project. Some of the highlights included: MRES is a nonprofit; the project is currently only being studied, hoping for a decision on whether the project will happen by 2025; MRES will pay taxes to both Gregory and Charles Mix Counties; and need licensing from the Federal Energy Regulation Commission. Various opponents also spoke. Some of the highlights included: use coal plants; windmills; electricity generated goes into overall market; will the water stored be sold; impact to fish and wildlife; impact to irrigation; impact to scenery; eminent domain authority; tribal concerns; crime; and housing concerns. More information will be gathered. No action was taken.

Recess:

The Commission meeting was at ease from 11:23 am-11:30 am as the Courtroom was cleared and the Commissioners moved the meeting to the Commission Room on 2nd Floor.

Lake Andes Extra-Territorial Jurisdiction:

The Lake Andes City Attorney, Tim Whalen, visited regarding the possibility of Lake Andes creating a 1-mile Extra-Territorial Jurisdiction around the boundary of Lake Andes in future zoning discussions. More information will be gathered. No action was taken.

Highway Department:

Superintendent Doug Cimpl explained that 3 bids were received for the new Highway Department Shop south of Lake Andes and each bid was opened at 11:45 am.

Summit Contracting - \$1,217,213.12 Scott Doom Contracting - \$1,290,000.00 Wagner Building & Supply - \$1,336,129.72 Discussion was held with no action taken.

Executive Session:

A motion was made by Mushitz and seconded by Soukup to enter into executive session at 11:54 am with States Attorney Steve Cotton, Superintendent Cimpl, and Auditor Gant present to discuss personnel per SDCL 1-25-2. All in favor, motion carried.

An end to executive session was declared at 11:59 am with no action taken.

Highway Department:

A motion was made by Mushitz and seconded by Soukup to accept the bid of Summit Contracting of \$1,217,213.12 for the new Highway Department Shop in Lake Andes. All in favor, motion carried.

Register of Deeds

Discussion was held on staffing for the Register of Deeds office. No action taken.

Charles Mix County Soil Conservation District

Representatives from the Charles Mix County Soil Conservation District visited with the Commission about funding levels for the 2023 budget year and various plans for the upcoming year. No action taken.

Mileage Rate

A motion was made by Soukup and seconded by Mushitz to approve the new mileage rates as approved by the state. All in favor, motion carried.

Auditor Update:

Auditor Gant reviewed the upcoming 2023 Budget Hearing on Tuesday, September 6, election misinformation update, and special check run if necessary. No action taken.

Next Meetings:

The next meetings are at 10:00 am on Tuesday, September 6th and Thursday, September 22nd.
