The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, November 10, 2022. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Colin Soukup, Commissioner Keith Mushitz, and Auditor Jason Gant present.

Gravel Road Speed Limit Ordinance:

Discussion was held on the second reading of the proposed Ordinance. The Ordinance changes the speed limit on the portion of 386th Avenue that runs North and South between South Dakota Highways 50 and 46. A motion was made by Soukup and seconded by Mushitz to approve the Ordinance. All in favor, motion carried.

Ordinance No. 2022--101

An ordinance regulating speed limit enforcement over a portion of 386th Avenue in Charles Mix County and further providing penalties for violation of the terms of the ordinance and repealing all prior ordinances in conflict with the provision of this ordinance.

WHEREAS, recent construction on other highways located in Charles Mix County has increased the vehicular travel on the portion of 386th avenue that runs North and South between SD highway 50 and SD highway 46, this increased usage has created hazardous conditions related to visibility and heavier traffic flow; and

WHEREAS, State Law SDCL 32-25-9.1 gives the county the authority determine and establish the speed zones upon any highway under its jurisdiction; and

WHEREAS, the Board of Charles Mix County Commissioners desires the enforcement of speed limitation on the portion of 386^{th} Avenue running North and South between SD highways 50 and 46, as set forth and posted by the Charles Mix County Highway Superintendent.

NOW THEREFORE, BE IT ORDAINED BY THE CHARLES MIX COUNTY COMMISSION: The speed limit on the portion of 386th Avenue as described above shall be set at forty-five (45) miles per hour (mph) which will be designated by the posting of signs. Further, the Charles Mix County Sheriff's Office is hereby authorized to enforce speed limitations and Charles Mix County requests that the Charles Mix County Sheriff assist in enforcing said speed limitations.

- 1. Purpose: To protect the health, safety and general welfare of the residents of Charles Mix County by enforcing vehicle speed limits on 386th Avenue as described above.
- 2. Unlawful Acts: It shall be unlawful to operate any "vehicle," as hereinafter defined, on the portion of 386th Avenue described above, within Charles Mix County, at a speed greater than that provided for herein.
- 3. Definitions:

A. Vehicle: Any motor vehicle.

- 4. Posting of Restrictions: Signs shall be posted in order to identify the speed limitations that are being enforced on 386th Avenue. Signs shall be posted at locations determined by the County Highway Superintendent, and approved by the Charles Mix County Commissioners.
- 5. Penalty: Any person violating any provision of this ordinance shall be guilty of a misdemeanor, punishable upon conviction by a fine not to exceed five hundred (\$500.00) dollars, plus costs and/or imprisonment in the county jail for a period not to exceed thirty (30) days.
- 6. Severability: This ordinance and the various parts, sections, paragraphs, and subsections, sentences, phrases, and clauses thereof are hereby declared to be severable. If a court of competent jurisdiction adjudges any part, section, paragraph, subsection, sentence, phrase, or clause unconstitutional or invalid, it is hereby provided that the remainder of this ordinance shall not be affected thereby.
