Regular Session – January 26, 2023

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, January 26, 2023, in the Commission Room. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup and Auditor Jason Gant present.

Agenda:

A motion was made by Soukup and seconded by Mushitz to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the January 12, 2023, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for January 26, 2023. All in favor, motion carried.

County Owned Property:

GIS Coordinator Karen Krcil and Auditor Gant reviewed with the Commission 36 various properties across the County that are currently owned by the County. Twelve of the properties are currently used by the County such as the Courthouse, Highway Shops, etc. Eight properties are from FEMA flood activities from 2019 and cannot be sold. Sixteen properties were acquired by the County via tax deeds and were unable to be sold in the past. Discussion was held regarding how the properties were acquired, where the properties are located, and potential plans for selling the 16 properties later this year. More discussion and final plans will take place at a later date. No action taken.

Highway Department:

Superintendent Doug Cimpr reviewed with the Commission the Township 5-year plans that were received, the Township grant requests that were received, the status of the Geddes Highway Shop, and the contracts from the bid awarding. No action taken.

Public Comment:

Sharon Drapeau and Faith Spotted Eagle visited with the Commission regarding the White Swan Cemetery, future White Swan campgrounds, and the Gregory Pump Station. No action taken.

A motion was made by Soukup and seconded by Mushitz
to approve the resignation of Erica Brandt as Jailer effective 1/11/23
to approve the hire of Kevin Oberbroekling as Jailer effective 1/25/23 at a rate of
\$19.26/hour
All in favor, motion carried.

Funeral Assistance:

Discussion was held regarding a request for Funeral Assistance. A motion was made by Soukup and seconded by Mushitz to approve the Funeral Assistance for M.A.L. All in favor, motion carried.

Gregory County Pump Storage:

Commissioner Stotz and Commissioner Mushitz updated the Commission on the meeting they attended regarding the Gregory County Pump Storage public meeting held in Burke on January 25th. No action taken.

Auditor Update:

Auditor Gant reviewed the tax bills for 2023, federal funds, meeting in Pierre with Legislators regarding election legislation, jail study information from the Legislature, and new front door security. No action taken.

Next Meetings:


The next meetings are at 10:00 am on Thursday, February 9th, and Thursday, February 23rd.
