Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, and Auditor Jason Gant present.

Agenda:

Charles Mix County Designee Appointment for Fire Suppression Assistance RESOLUTION 2023-02 February 23, 2023

WHEREAS, in the event of an emergency wildland fire in Charles Mix County, the County may require assistance to suppress the fire; and,

WHEREAS, quick and decisive action is necessary in the event of a wildland fire for the safety of human life, livestock and individuals' properties; and,

WHEREAS, the South Dakota Department of Public Safety, Wildland Fire Division, is able to offer certain forms of assistance to Charles Mix County at no cost, per SDCL 41-20A-11; NOW THEREFORE BE IT RESOLVED, that the Charles Mix County Commission appoints Commissioner Nick Stotz as its designee who will have the authority to obligate County funds in the event a request for fire suppression assistance from the State of South Dakota is required; and BE IT FURTHER RESOLVED, that Commissioner Nick Stotz shall serve as the Charles Mix County designee for the term of January 1, 2023 through December 31, 2023.
