The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, June 8, 2023, in the Commission Room. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, States Attorney Steve Cotton, and Auditor Jason Gant present.

Agenda:

Sheriff Update:

Sheriff Randy Thaler discussed with the Commission the new Minnehaha County Juvenile Detention Center rates and other juvenile facilities. No action taken.

Rural Attorney Recruitment Program:

Beau Barrett, an attorney, visited with the Commission regarding the Rural Attorney Recruitment Program administered by the South Dakota Unified Judicial System. Mr. Barrett is planning on starting a law practice in Wagner and provided the Commission with the agreement from the City of Wagner to pay half of the program cost. The program pays \$62,568 over five years with the County being responsible for \$2,189.88 per year and the City of Wagner being responsible for \$2,189.88 for five years with the State paying the remaining.

A motion was made by Soukup and seconded by Stotz to approve the Rural Attorney Recruitment Program Agreement to pay \$2,189.88 per year for five years. All in favor, motion carried.

ExtraTerritorial Jurisdictions:

Tim Whalen, city attorney for Lake Andes and Platte, discussed with the Commission the request from Lake Andes and Platte to begin the process of setting up an ExtraTerritorial Jurisdiction (ETJ) around the city. Also discussed were legal notices, public hearings, and timelines. The plan is to detail the process at the next meeting. No action taken.

Geddes Highway Shop Bids:

Superintendent Doug Cimpl opened the three bids regarding the building of the new Geddes Highway Shop. The three bids included:

Auditor Gant reviewed the plan for a special check run on June 15th, having Commission meetings once a year in Platte, Geddes, and Wagner, new concrete walkway near front door of Courthouse, need for new concrete stairs for the South entrance to Courthouse, and District III letter. No action taken.

The next Commission meetings are at 10:00 am on Thursday, June 22nd at the Courthouse and at 10:00 am on Thursday, July 13th in Wagner at the Wagner Highway Shop at 29681 397th Avenue.
