**Regular Session – June 22, 2023**

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, June 22, 2023, in the Commission Room. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, and Auditor Jason Gant present.

**Agenda:**

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

**Minutes:**

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the June 8, 2023, Board of Commissioners regular meeting. All in favor, motion carried.

**Bills:**

A motion was made by Soukup and seconded by Mushitz to approve the bills for June 15, 2023. All in favor, motion carried.

A motion was made by Soukup and seconded by Mushitz to approve the bills for June 22, 2023. All in favor, motion carried.

**New Pickup Bids:**

Vice Chairman Mushitz opened the bids for the two new pickup trucks. The bids included:

**Highway Department:**

Superintendent Doug Cimpl visited with the Commission regarding the plow on one of the trucks, the new Geddes Highway Shop, the future of the current Lake Andes Highway building, gravel, mowing plan, and an update on the new Lake Andes Highway Shop. Discussion was also held with Grant Doom of Wagner Building Supply about the new Geddes Highway Shop. No action taken.

**Sheriff:**

Sheriff Randy Thaler visited with the Commission regarding the failing health status of drug dog Diesel. With the increase in Juvenile Detention costs in Minnehaha County, Sheriff Thaler presented an additional Juvenile Detention contract with Beadle County.

A motion was made by Mushitz and seconded by Soukup to approve Juvenile Detention contract with Beadle County at \$200/day. All in favor, motion carried.

**Executive Session:**

A motion was made by Mushitz and seconded by Soukup to enter into executive session at 10:44 am with Sheriff Thaler and Auditor Gant present to discuss personnel per SDCL 1-25-2. All in favor, motion carried.

An end to executive session was declared at 10:58 am with no action taken.

**ExtraTerritorial Jurisdictions:**

Tim Whalen, city attorney for Lake Andes, Geddes, and Platte, discussed with the Commission the request from Lake Andes, Geddes, and Platte to begin the process of setting up an ExtraTerritorial

Jurisdiction (ETJ) around the city. Also discussed were legal notices, public hearings, and timelines. No action taken.

**Attorney Hire:**

A motion was made by Mushitz and seconded by Soukup to hire Tim Whalen, attorney, for additional legal services at \$500. All in favor, motion carried.

**Personnel:**

A motion was made by Soukup and seconded by Mushitz to

**Courthouse Closed:**

A motion was made by Soukup and seconded by Mushitz to close the Courthouse on Monday, July 3<sup>rd</sup> due to the State closing all offices. All in favor, motion carried.

**Auditor Update:**


