Regular Session – August 10, 2023

The Charles Mix County Board of Commissioners met in Regular Session at the County Highway Shop in Platte on Thursday, August 10, 2023. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, States Attorney Steve Cotton, and Auditor Jason Gant present.

Open House:

An Open House was held from 9-10 at the County Highway Shop in Platte. A large group of people showed up to tour the Highway Shop, visit with the Commissioners, and enjoy a donut and coffee.

Agenda:

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the July 27, 2023, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for August 10, 2023. All in favor, motion carried.

Auditor Report:

A motion was made by Mushitz and seconded by Soukup to approve the Auditor’s Account with Treasurer for the month ending July 31, 2023, for \$9,785,757.27. All in favor, motion carried.

Register of Deeds Report:

A motion was made by Mushitz and seconded by Soukup to approve the Register of Deeds Statement of Fees collected during the month ending July 31, 2023, in the amount of \$6,426.50. All in favor, motion carried.

Plats:

A motion was made by Soukup and seconded by Mushitz to approve the PLAT of Tracts 1, 2, 3, 4, and 5 of Lot A of Lot 3, Wagner Area Growth Addition in the SW1/4 of the SE1/4 and in the SE1/4 of the SE1/4 of Section 35, T96N, R63W of the 5th P.M., Bryan Township near 397th Ave and 297th St, Charles Mix County, South Dakota. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Tract 1 of Pheifer Addition in the SW1/4 of the NW1/4 of Section 18, T99N, R67W of the 5th P.M., Darlington Township near 368th Ave and 275th St, Charles Mix County, South Dakota. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Lots A & B in Lot 2 of Block 2 of Kuiper Addition to the City of Platte along Pheasant Lane, Charles Mix County, South Dakota. All in favor, motion carried.

Charles Mix County Storm Water Evaluation:

Scott Schweitzer and Eric Prunty with Brosz Engineering, presented the final report of the storm water study for the drainage basins in the Darlington, Jackson, Platte, Rhoda, and Signal Townships and the City of Platte. The purpose of the study was to determine the condition of the County’s drainage ways and identify any upgrades or improvements needed for its stormwater system to function effectively. Models of water levels were presented showing how new investments in additional culverts, berms, and other water ways would move water more efficiently in the future.

The Commissioners, City of Platte representatives, and numerous public comments, discussions, and questions took place. No action taken.

Highway Department:

Superintendent Doug Cimpl presented quotes received for a new wheel loader.

A motion was made by Mushitz and seconded by Soukup to approve the purchase of a new CAT 950GC wheel loader at a cost of \$307,160.21. All in favor, motion carried.

Speed Limit Ordinance:

Superintendent Cimpl and States Attorney Cotton presented Ordinance No. 2023-201 to reduce the speed limit on 282nd Street that runs in between 359th Avenue and 360th Avenue near the Platte Creek Recreation Area to thirty (30) miles per hour.

A motion was made by Soukup and seconded by Mushitz to approve Ordinance No. 2023-201. All in favor, motion carried.

Ordinance No. 2023--201

An ordinance regulating speed limit enforcement over a portion of 282nd Street in Charles Mix County and further providing penalties for violation of the terms of the ordinance and repealing all prior ordinances in conflict with the provision of this ordinance.

WHEREAS, State Law SDCL 32-25-9.1 gives the county the authority to determine and establish the speed zones upon any highway under its jurisdiction; and

WHEREAS, the Board of Charles Mix County Commissioners desires the enforcement of speed limitation on the portion of 282nd Street that runs in between 359th Avenue and 360th Avenue, as set forth and posted by the Charles Mix County Highway Superintendent.

NOW THEREFORE, BE IT ORDAINED BY THE CHARLES MIX COUNTY COMMISSION: The speed limit on the portion of 282nd Street as described above shall be set at thirty (30) miles per hour (mph) which will be designated by the posting of signs. Further, the Charles Mix County Sheriff’s Office is hereby authorized to enforce speed limitations and Charles Mix County requests that the Charles Mix County Sheriff assist in enforcing said speed limitations.

1. Purpose: To protect the health, safety and general welfare of the residents of Charles Mix County by enforcing vehicle speed limits on 282nd Street as described above.
2. Unlawful Acts: It shall be unlawful to operate any “vehicle,” as hereinafter defined, on the portion of 282nd Street described above, within Charles Mix County, at a speed greater than that provided for herein.
3. Definitions:
 - A. Vehicle: Any motor vehicle.
4. Posting of Restrictions: Signs shall be posted in order to identify the speed limitations that are being enforced on 282nd Street. Signs shall be posted at locations determined by the County Highway Superintendent, and approved by the Charles Mix County Commissioners.
5. Penalty: Any person violating any provision of this ordinance shall be guilty of a misdemeanor, punishable upon conviction by a fine not to exceed five hundred (\$500.00) dollars, plus costs and/or imprisonment in the county jail for a period not to exceed thirty (30) days.
6. Severability: This ordinance and the various parts, sections, paragraphs, and subsections, sentences, phrases, and clauses thereof are hereby declared to be severable. If a court of competent jurisdiction adjudges any part, section, paragraph, subsection, sentence, phrase, or clause unconstitutional or invalid, it is hereby provided that the remainder of this ordinance shall not be affected thereby.



Platte-Winner Bridge:

A motion was made by Mushitz and seconded by Soukup to approve and sign the letter of support for the new Platte-Winner Bridge to the Secretary of the US Department of Transportation. All in favor, motion carried.

Personnel:

A motion was made by Soukup and seconded by Stotz to approve the hire of Gina McCarthy as part time 4-H Extension Assistant at \$17.12 per hour effective 7/27/23. Soukup and Stotz in favor, Mushitz abstaining, motion carried.

Upcoming Commission Dates:

Auditor Gant explained the need to move the September 14th meeting to September 5th due to Budget Hearings and moving November 23rd meeting to November 30th due to Thanksgiving.

A motion was made by Mushitz and seconded by Soukup to approve the date changes. All in favor, motion carried.

2024 Provisional Budget:

Auditor Gant reviewed the 2024 Provisional Budget with the Commission. The Consumer Price Index (CPI) was 3% and the County Growth was 1.95% allowing the County to increase revenue by 4.95%. Budget Hearings will be at the next Commission meetings on Tuesday, September 5th and Thursday September 28th, with final passage of the 2024 Adopted Budget on Thursday, September 28th.

A motion was made by Soukup and seconded by Mushitz to approve the 2024 Provisional Budget. All in favor, motion carried.

2023 Surplus Sale:

Auditor Gant reviewed the Online Surplus Sale results that took place on July 27th. The property sales ranged from \$2,500 to \$6,500 and the vehicles ranged from \$3,400 to \$14,750. Total sales were \$60,200.00 with \$7,432.76 in expenses for a net profit of \$52,767.24. No action taken.

Auditor Update:

Auditor Gant reviewed the Platte-Geddes School District funding, the County will own properties that have unpaid property taxes effective August 25 with an online auction sale planned for September 28, and purchasing an Ancestry.com subscription for Veteran Services. No action taken.

Next Meetings:


