# CHARLES MIX COUNTY Board of Commissioners Regular Session – August 24, 2023

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, August 24, 2023, in the Commission Room. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, and Auditor Jason Gant present.

# Agenda:

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

# Minutes:

A motion was made by Mushitz and seconded by Soukup to approve the minutes from the August 10, 2023, Board of Commissioners regular meeting. All in favor, motion carried.

#### Bills:

A motion was made by Soukup and seconded by Mushitz to approve the bills for August 24, 2023. All in favor, motion carried.

## Plats:

A motion was made by Soukup and seconded by Mushitz to approve the PLAT of Tract 1 in Lot F being a Subdivision of a Portion of Government Lot 6, located in Section 3, T96N, R65W of the  $5^{th}$  P.M., White Swan Township near  $383^{rd}$  Ave and  $292^{nd}$  St, Charles Mix County, South Dakota. All in favor, motion carried.

A motion was made by Mushitz and seconded by Soukup to approve the PLAT of Lot 1, Qualm Second Subdivision located in the SW1/4 of Section 13, T99N, R70W of the 5<sup>th</sup> P.M., La Roche Township near 355<sup>th</sup> Ave and SD Hwy 44, Charles Mix County, South Dakota. All in favor, motion carried.

# **Highway Department:**

Superintendent Doug Cimpl updated the Commission on returning the speed limit on 386<sup>th</sup> Avenue between SD Highway 50 and SD Highway 46 back to 55 mph, new Lake Andes Highway Shop update, gravel purchases, and Geddes Shop update. It was agreed to just trade-in the heavy equipment versus selling at public auction, however should another government wish to purchase them, that would be considered. No action taken.

# **Emergency Management Department:**

Emergency Management Director Mike Kotab updated the Commission on H&H Study, fire department grants, radios, and office duties. No action taken.

# 4-H Extension:

4-H Youth Program Advisor Lesley Rygaard updated the Commission on Achievement Days, school programming, updating facilities, and increasing participation in 4-H. No action taken.

# Personnel:

A motion was made by Stotz and seconded by Soukup to approve the termination of Gina McCarthy as part time 4-H Extension Assistant effective 8/24/23. Soukup and Stotz in favor, Mushitz abstaining, motion carried.

# **Speed Limit Ordinance:**

The second reading of Ordinance No. 2023-201 to reduce the speed limit on 282<sup>nd</sup> Street that runs in between 359<sup>th</sup> Avenue and 360<sup>th</sup> Avenue near the Platte Creek Recreation Area to thirty (30) miles per hour took place.

A motion was made by Soukup and seconded by Mushitz to approve Ordinance No. 2023-201. All in favor, motion carried.

### Ordinance No. 2023--201

An ordinance regulating speed limit enforcement over a portion of 282<sup>nd</sup> Street in Charles Mix County and further providing penalties for violation of the terms of the ordinance and repealing all prior ordinances in conflict with the provision of this ordinance.

WHEREAS, State Law SDCL 32-25-9.1 gives the county the authority to determine and establish the speed zones upon any highway under its jurisdiction; and

WHEREAS, the Board of Charles Mix County Commissioners desires the enforcement of speed limitation on the portion of 282<sup>nd</sup> Street that runs in between 359<sup>th</sup> Avenue and 360<sup>th</sup> Avenue, as set forth and posted by the Charles Mix County Highway Superintendent.

NOW THEREFORE, BE IT ORDAINED BY THE CHARLES MIX COUNTY COMMISSION: The speed limit on the portion of 282<sup>nd</sup> Street as described above shall be set at thirty (30) miles per hour (mph) which will be designated by the posting of signs. Further, the Charles Mix County Sheriff's Office is hereby authorized to enforce speed limitations and Charles Mix County requests that the Charles Mix County Sheriff assist in enforcing said speed limitations.

- 1. Purpose: To protect the health, safety and general welfare of the residents of Charles Mix County by enforcing vehicle speed limits on 282<sup>nd</sup> Street as described above.
- 2. Unlawful Acts: It shall be unlawful to operate any "vehicle," as hereinafter defined, on the portion of 282<sup>nd</sup> Street described above, within Charles Mix County, at a speed greater than that provided for herein.

#### 3. Definitions:

A. Vehicle: Any motor vehicle.

- 4. Posting of Restrictions: Signs shall be posted in order to identify the speed limitations that are being enforced on 282<sup>nd</sup> Street. Signs shall be posted at locations determined by the County Highway Superintendent, and approved by the Charles Mix County Commissioners.
- 5. Penalty: Any person violating any provision of this ordinance shall be guilty of a misdemeanor, punishable upon conviction by a fine not to exceed five hundred (\$500.00) dollars, plus costs and/or imprisonment in the county jail for a period not to exceed thirty (30) days.
- 6. Severability: This ordinance and the various parts, sections, paragraphs, and subsections, sentences, phrases, and clauses thereof are hereby declared to be severable. If a court of competent jurisdiction adjudges any part, section, paragraph, subsection, sentence, phrase, or clause unconstitutional or invalid, it is hereby provided that the remainder of this ordinance shall not be affected thereby.
