## **Highway Department:**

Superintendent Doug Cimpl updated the Commission that three design grants were awarded to the County for bridge improvements, discussed wages, five Townships submitted their 5-Year Plans for grants for 2024, and discussed the status of the Lake Andes Highway Shop.

#### 2024 Provisional Budget:

Auditor Gant reviewed the 2024 Provisional Budget with the Commission. The Consumer Price Index (CPI) was 3% and the County Growth was 1.90% allowing the County to increase revenue by 4.90%. Budget Hearings were held. Final passage of the 2024 Adopted Budget will be on Thursday, September 28<sup>th</sup>.
