CHARLES MIX COUNTY Board of Commissioners Regular Session – October 26, 2023

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Thursday, October 26, 2023, in the Commission Room. Chairman Nick Stotz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Keith Mushitz, Commissioner Colin Soukup, States Attorney Steve Cotton, and Auditor Jason Gant present.

Agenda:

A motion was made by Mushitz and seconded by Soukup to approve the agenda. All in favor, motion carried.

Minutes:

A motion was made by Soukup and seconded by Mushitz to approve the minutes from the October 12, 2023, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion was made by Mushitz and seconded by Soukup to approve the bills for October 26, 2023. All in favor, motion carried.

Public Comments:

CJ Jones visited with the Commission regarding concerns about law enforcement jurisdiction along the Missouri River and cooperation with neighboring Counties.

Plats:

A motion was made by Stotz and seconded by Soukup to approve the PLAT of Lot 4 in the Honke Addition in the SW1/4 of Section 21, T96N, R65W of the 5th P.M., White Swan Township near 382nd Ave and 295th St, Charles Mix County, South Dakota. All in favor, motion carried.
