CHARLES MIX COUNTY Board of Commissioners Regular Session – October 24, 2024

The Charles Mix County Board of Commissioners met in Regular Session at the County Highway Shop in Geddes on Thursday, October 24, 2024. Chairman Keith Mushitz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Colin Soukup, Commissioner Nick Stotz, State's Attorney Steve Cotton, and Auditor Jason Gant present.

Open House:

An Open House was held from 9-10 at the new County Highway Shop in Geddes. A handful of people showed up to tour the Highway Shop, visit with the Commissioners, and enjoy a donut and coffee.

Agenda:

A motion by Stotz and second by Soukup to approve the agenda. All in favor, motion carried.

Minutes:

A motion by Soukup and second by Stotz to approve the minutes from the October 10, 2024, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion by Soukup and second by Stotz to approve the bills for October 24, 2024. All in favor, motion carried.

Plats:

A motion by Soukup and second by Stotz to approve the PLAT of Laska's Addition located in the NE 1/4 of the SE 1/4 of Section 32, T96N, R65W of the 5th P.M., White Swan Township near 382nd Ave and 297th St, Charles Mix County, South Dakota. All in favor, motion carried.

A motion by Stotz and second by Soukup to approve the PLAT of PNB Tract 1 in the SW 1/4 of the SW 1/4 of Section 8, T97N, R63W of the 5th P.M., Kennedy Township near 393rd Ave and 287th St, Charles Mix County, South Dakota. All in favor, motion carried.

Drainage Hearing:

The Public Hearing was opened with no protest present. A motion by Stotz and second by Soukup to approve Drainage Permit 2024-04 of David Scott for the E ½ of Section 35, Township 98N, Range 67W, Rhoda Township, near the intersection of 373rd Avenue and 285th Street, Charles Mix County, South Dakota. All in favor, motion carried.

The Public Hearing was opened with no protest present. A motion by Stotz and second by Soukup to approve Drainage Permit 2024-05 of Terry Hochhalter for the S½ of the SW¼ of Section 20, Township 98N, Range 64W, Howard Township, near the intersection of 387th Avenue and 283rd Street, Charles Mix County, South Dakota. All in favor, motion carried.

Alcoholic Beverage Licenses:

Auditor Gant presented 7 of the 10 Alcoholic Beverage Licenses for renewal effective January 1, 2025.

Highway Department:

Superintendent Cimpl reviewed the Geddes Shop, D-ware computer program, and FEMA. No action taken.

A motion by Stotz and second by Soukup to approve payment to Lone Tree Township in the amount of \$26,713.67 for additional RAIF qualified expenses. All in favor, motion carried.

A motion by Soukup and second by Stotz to approve the agreement with Greenwood HBI to place a permanent pipe beneath the intersection of 401st Avenue and 288th Street. All in favor, motion carried.

Sheriff:

Auditor Gant presented a contract with the City of Wagner for Dispatch Services.

A motion by Soukup and second by Stotz to approve the Law Enforcement Dispatch Agreement with the Wagner Police Department. All in favor, motion carried.

Courthouse Closed:

A motion by Stotz and second by Soukup to close the Courthouse on Monday, December 23rd and Tuesday, December 24th due to the State closing all offices. All in favor, motion carried.

Debris Site:

Auditor Gant reviewed the renewal application for the debris disposal site near the Wagner Highway Shop.

A motion by Soukup and second by Stotz to approve the SD Department of Agriculture and Natural Resources renewal application for the Debris Disposal Site and change the type from Type III to Type IV. All in favor, motion carried.

Assessor:

Director of Equalization Denise Weber discussed old SD Highway 50 near Wagner and mobile home ownership issues. No action taken.

Executive Session:

A motion by Soukup and second by Stotz to enter into executive session at 11:04 am with State's Attorney Cotton, Highway Superintendent Cimpl, and Auditor Gant present to discuss personnel per SDCL 1-25-2. All in favor, motion carried.

An end to executive session was declared at 11:24 am with no action taken. Superintendent Cimpl will visit with employees about county equipment.

Auditor Update:

Auditor Gant reviewed the upcoming General Election with 416 ballots mailed and 329 ballots received as of 10/23/24, cell phone policy was discussed, election night possible quorum, open meetings letter, snow plowing around county buildings, insurance claim on flooding in Courthouse basement, and election lawsuit update. No action taken.

The next Commission meetings are at 10:00 am on Thursday, November 7th at the Courthouse and on Thursday, November 21st at the Courthouse.
