CHARLES MIX COUNTY Board of Commissioners Regular Session – December 30, 2024

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse on Monday, December 30, 2024, in the Commission Room. Chairman Keith Mushitz opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Colin Soukup, Commissioner Nick Stotz, Commissioner-Elect Kory Standy, State's Attorney Steve Cotton, via phone, and Auditor Jason Gant present.

Agenda:

A motion by Soukup and second by Stotz to approve the agenda. All in favor, motion carried.

Minutes:

A motion by Stotz and second by Soukup to approve the minutes from the December 12, 2024, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion by Soukup and second by Stotz to approve the bills for December 20, 2024. All in favor, motion carried.

Plats:

A motion by Soukup and second by Stotz to approve the PLAT of Tract 1 of RCWD Addition, in the NE 1/4 of the SE 1/4 of Section 15, T98N, R68W of the 5th P.M., Signal Township near 366th Ave and 282nd St, Charles Mix County, South Dakota. All in favor, motion carried.

Sheriff Randy Thaler updated the Commission on recent activities and overviewed law enforcement and housing contracts for 2025.

A motion by Soukup and second by Stotz to approve the Prisoner Housing Agreement with the SD Department of Corrections for \$95 per day plus expenses. All in favor, motion carried.

A motion by Soukup and second by Stotz to approve the Beadle County Juvenile Detention Center Agreement for \$325 per day. All in favor, motion carried.

A motion by Soukup and second by Stotz to approve the Law Enforcement Services Agreement with the City of Lake Andes for \$154,000 per year. All in favor, motion carried.

Highway Department:

Foreman Jerry Horst reviewed fuel bids, culvert engineering, and gravel options. No action taken.

Contingency Transfers:

A motion by Soukup and second by Stotz to approve Resolution 2024-300. All in favor, motion carried.

Fund Creation:

A motion by Soukup and second by Stotz to approve and authorize the County Auditor to create a new Fund titled 601 Medical Expense Reimbursement Program (MERP) Fund effective January 1, 2025, and close the Andes State Bank Account Number 00094094 and transfer the remaining funds into the new 601 MERP Fund. All in favor, motion carried.

County Levies:

A motion by Soukup and second by Stotz to approve the final levy amounts, as approved by the Department of Revenue, of 3.074 for County General Funds of \$5,312,131 and of 0.490 for County Secondary Road Fund of \$40,000. All in favor, motion carried.

Cell Phone Policy:

A motion by Soukup and second by Stotz to approve, as of January 1, 2025, reimbursement of personal cell phone use to the following positions at a rate of \$30 per month or use of a County issued cell phone: Auditor, Deputy Auditor, Treasurer, Deputy Treasurer, Emergency Management Director, Emergency Management Assistant Director, State's Attorney, and Janitor; and at a rate of \$10 per month or use of a County issued cell phone: Director of Equalization. All in favor, motion carried.

Courthouse Propane Bids:

Various bids were received for 8,000 gallons of propane for the Courthouse for 2025 including: Lake Andes Coop of \$1.25 per gallon; Best Propane of \$1.45 per gallon; and 3D Oil & LP of \$1.22 per gallon.

A motion by Soukup and second by Stotz to approve the bid from 3D Oil & LP of 1.22 per gallon. All in favor, motion carried.

Auditor Update:

Auditor Gant reviewed the Highway Department budget, Private Applicator Training on February 12th at 4-H Center, next meeting dates, the employee appreciation lunch was appreciated, all .gov emails have been set up, and the Courthouse water line break was fixed and will be completely replaced in Spring 2025. No action taken.

Executive Session:

A motion by Stotz and second by Soukup to enter into executive session at 11:32 am with State's Attorney Cotton, Commissioner-Elect Standy, and Auditor Gant present to discuss personnel per SDCL 1-25-2. All in favor, motion carried.

An end to executive session was declared at 11:46 am with no action taken.

The next Commission meetings are at 10:00 am on Tuesday, January 7^{th} at the Courthouse and at 10:00 am on Thursday, January 23^{rd} at the Courthouse.
