## Resolution 2025-02 Fire Suppression Resolution

BE IT RESOLVED that the Charles Mix County Board of Commissioners adopts the following Resolution designating a Charles Mix County Commissioner as designee to request fire suppression assistance from South Dakota Wildland Fire, a Division of the South Dakota Department of Public Safety.

WHEREAS, pursuant to SDCL 41-20A-11, a person designated by the Board of County Commissioners may request the State Wildland Fire Coordinator to assist in the suppression of any range fire within the County; and

WHEREAS, the Charles Mix County Commission desires to designate a Charles Mix County Commissioner with the requisite authority to request the State Wildland Fire Coordinator to assist in the suppression of any range fire within Charles Mix County if such assistance is needed; and

WHEREAS, the Charles Mix County Commission designee shall have the authority to obligate Charles Mix County funds if such requires resources over the wildland fire resources provided pursuant to SDCL 41-20A-11; and

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Charles Mix County that pursuant to SDCL 41-20A-11, the Charles Mix County Commission designates Commissioner Colin Soukup as its designee to request the State Wildland Fire Coordinator to assist in the suppression of any range fire within the County, if such assistance is needed in Charles Mix County; and

IT IS FURTHER RESOLVED that such designation will continue for the designee's current term of office as a commissioner for Charles Mix County.
