# CHARLES MIX COUNTY Board of Commissioners Regular Session – August 28, 2025

The Charles Mix County Board of Commissioners met in Regular Session at the County Highway Shop in Wagner on Thursday, August 28, 2025. Chairman Colin Soukup opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Nick Stotz, Commissioner Kory Standy, State's Attorney Steve Cotton, and Auditor Jason Gant present.

## Open House:

An Open House was held from 9-10 at the County Highway Shop in Wagner. A handful of people showed up to tour the Highway Shop, visit with the Commissioners, and enjoy a donut and coffee.
