CHARLES MIX COUNTY Board of Commissioners Regular Session – October 23, 2025

The Charles Mix County Board of Commissioners met in Regular Session at the County Courthouse in Lake Andes on Thursday, October 23, 2025, in the Commission Room. Chairman Colin Soukup opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Vice Chairman Nick Stotz, Commissioner Kory Standy, State's Attorney Steve Cotton, and Auditor Jason Gant present.

Agenda:

A motion by Stotz and second by Standy to approve the agenda. All in favor, motion carried.

Minutes:

A motion by Stotz and second by Standy to approve the minutes from the October 9, 2025, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion by Stotz and second by Standy to approve the bills for October 23, 2025. All in favor, motion carried.

Plats:

A motion by Soukup and second by Standy to approve the PLAT of Tract 1, 2, 3, and 4 of Hitzeman Addition in the SE 1/4 of Section 4, T97N, R65W of the 5^{th} P.M., Goose Lake Township near 383^{rd} Ave and 286^{th} St, Charles Mix County, South Dakota. All in favor, motion carried.

Alcoholic Beverage Licenses:


