CHARLES MIX COUNTY Board of Commissioners Special Session – June 9, 2026

The Charles Mix County Board of Commissioners met in Special Session at the County Courthouse on Tuesday, June 9, 2026, in the Commission Room. Chairman Colin Soukup opened the meeting with the Pledge of Allegiance and called the meeting to order at 10:00 am with Commissioner Nick Stotz, State’s Attorney Steve Cotton, and Auditor Jason Gant present, with Vice Chairman Kory Standy absent.

Agenda:

A motion by Soukup and second by Stotz to approve the agenda. All in favor, motion carried.

Minutes:

A motion by Soukup and second by Stotz to approve the minutes from the June 4, 2026, Board of Commissioners regular meeting. All in favor, motion carried.

Bills:

A motion by Stotz and second by Soukup to approve the bills for June 9, 2026. All in favor, motion carried.

Marty Polling Location:

The Yankton Sioux Tribe sent a letter to the County stating the Marty Community Building would no longer be available to rent for any future elections.

A motion by Stotz and second by Soukup to eliminate and merge Precinct 04 (Marty, Highland Township, and Wahehe Township) with Precinct 01 which votes at the Wagner Armory; as well as place advertisements in newspapers, radio, and mail postcards to all registered voters in Precinct 04 prior to the Runoff Election and the General Election in 2026. All in favor, motion carried.

Ravinia Polling Location:

Due to a lack of voters, the need for the Ravinia polling location is no longer feasible.

A motion by Stotz and second by Soukup to eliminate and merge Precinct 13 (Ravinia and Plain Center Township) with Precinct 01 which votes at the Wagner Armory; as well as place advertisements in newspapers, radio, and mail postcards to all registered voters in Precinct 13 prior to the Runoff Election and the General Election in 2026. All in favor, motion carried.

Lake Andes Polling Location:

Due to the 4-H County Fair taking place during the Runoff Election on July 28, the 4-H Center is not available to be the polling location.

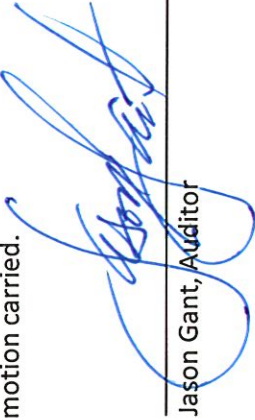
A motion by Stotz and second by Soukup to move Precinct 05 and Precinct 06 (Lake Andes, Goose Lake Township, Howard Township, and White Swan Township) polling location from the 4-H Center to the Lake Andes Community Center for only the Runoff Election on July 28; as well as place advertisements in newspapers, radio, and mail postcards to all registered voters in Precinct 05 and Precinct 06 prior to the Runoff Election in 2026; the 4-H Center will be used for the General Election. All in favor, motion carried.
