County Sales Tax Public Hearing:

Auditor Gant presented an overview of Senate Bill 96 from the 2026 Legislative Session which allows a County to implement a 0.5% sales tax to reduce owner occupied property taxes. If the County sales tax were implemented, a \$200,000 house would see a reduction of \$600 per year. Public comments and questions took place.

Highway Department:

Superintendent Doug Cimpl reviewed the Geddes Oil Road striping and tonnage signage, Wahehe bridge, Wagner bridge, and Academy bridge.

Sheriff:

Sheriff Randy Thaler discussed jail contracts with neighboring Counties, jail staffing, and 911 service without Douglas County as well as a state grant to provide transition funds.

A motion by Stotz and second by Standy to approve the jail housing contracts with Edmunds County, Clay County, and the City of Winner. All in favor, motion carried.

2027 Provisional Budget:

Auditor Gant reviewed the 2027 Provisional Budget detailing revenue and expenditure estimates with \$10,692,000 in estimated revenue and expenses.
